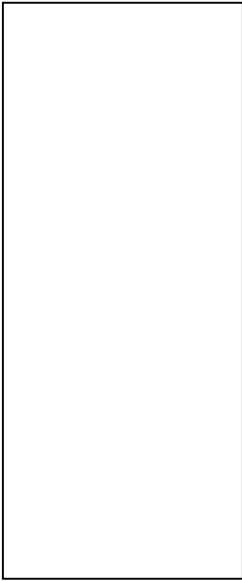

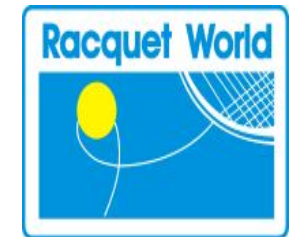
Accommodations
